

Phil Harvey has been an artist and nature photographer for over thirty years. Harvey has an eye for the light of life as he creatively captures the essence of those moments that take our breath away. This gifted photographer expresses this essence in his collection of "Mystique of Ojai" images.

A man of many talents, Harvey has a long history as a professional actor/singer in opera, light opera, television and movies. He was the Musical Director at the Ojai Presbyterian Church for 15 years, founded the Ojai Community Chorus in 1987 and currently serves as its Artistic Director.

The Ojai Camera Club was founded by Harvey in 1984, and this group continues today as the Ojai Photography Club. In 2003, he received the City of Ojai's "Lifetime Achievement in the Arts Award." The Rotary Club honored him as an Ojai "Living Treasure" in 2010.
